Occupational therapists that are registered in another Canadian jurisdiction will not require registration in Nova Scotia if they were providing only virtual-care services; allowing the Virtual-Care Only Provisional category of registration to be closed.
 Occupational therapists who will be providing in-person care in Nova Scotia will continue to require registration and licensure in Nova Scotia.
